#### PUBLIC COMMENTS ON CLOSED SESSION AGENDA ITEMS

# Florence Adams-Vickers-Chairperson

Expressed her concern about the Plant Worker Substitute employees having to take another exam to become permanent Plant Staff. Commission Adams-Vickers feels that the substitute employees are being over tested and would like to find a way to incorporate a rating sheet from there supervisor on how they have worked in the substitute capacity and use that instead of more testing.

#### Laurence Adams-Senior Executive Director

Mr. Adams informed Commissioner Irving that based on what the Commission asked, substitutes are no longer required to take a written test to become permanent, but they are required to take a performance or oral exam. Then they will be placed on the eligibility list based on that exams score.

# Janice Irving-Commissioner

Commissioner Irving asked Mr. Adams if the performance exam testers will be graded based on each activity asked to complete. For example: proper mixing of chemicals for floor cleaning.

# Laurence Adams-Senior Executive Director

Mr. Adams responded to Commissioner Irving that each component of the exam has its own weight; they will all have an equal score.

#### Janice Irving-Commissioner

Commissioner Irving asked Mr. Adams if the evaluators are aware that each component is an individual score.

#### Laurence Adams-Senior Executive Director

Mr. Adams responded to Commissioner Irving that each evaluator is provided with a scoring rubric by which to score each applicant on the same criteria.

#### Janice Irving-Commissioner

Suggested a look at programs like CETA where there is on the job training. She strongly feels that the supervisors should be able to submit a rating that counts as a part of the applicants score.

#### Laurence Adams-Senior Executive Director

Understands what the Commission is asking and will investigate this in context with the merit rules and bring back a report to the commission on findings.

## Jonathan Taylor-Commission Co-Chairperson

Believes the suggestions of Commissioner Irving and Commissioner Adams are great ways to assert motivation in substitutes when they feel that can become permanent employees.

## Jonathan Taylor-Commission Co-Chairperson
