PUBLIC COMMENTS ON AGENDA AND NON-AGENDA ITEMS

Public Comments:

Shawn Poole-Lewis, Sr. Community Relations Specialist of the District Parent Center, questioned the Commissioners about the layoff that took place of the Community Relations Specialists, and one that was rescinded. Ms. Poole stated she was concerned on how many were laid off, and how many were going to return because the schools that were left without a Community Relations Specialists, the Sr. Community Relations Specialists were going to have to cover the schools that were affected.

Mr. Jonathan Taylor, Vice Chairperson directed the question Ms. Poole had to Mr. Adams, Sr. Director of Classified Personnel, and where Ms. Poole can retrieve the information.

Mr. Adams, Sr. Director of Classified Personnel stated that the information can be given to Ms. Poole publicly. Mr. Adams informed Ms. Poole that he met with Union CSEA and they were informed of the six (6) who were laid off, and two (2) involuntary demotions. Mr. Adams

informed Ms. Lewis that three (3) of the six (6) that were laid off will be rescinded, and one (1) Sr. Community Relations Specialist will also be rescinded.

Mr. Adams also informed Ms. Lewis since the positions are funded out of categorical funds, the School Site Council determine how the categorical funds will be used. Some School Site Councils eliminated the position from their schools, and some cut the positions in half, and as a result of that, three (3) fulltime positions were reduced.

Mr. Adams also advised Ms. Lewis to attend a meeting CSEA was going to conduct, and there she would also receive additional information regarding the lay off.
