So this is the 2016-2017 Personnel Commission Proposed Budget. You have the printout before you. We are reporting that this budget is the same as our 2015-2016 total cost. There is no increase in the totals for this year. The Commission is proposing the same amount for this school year 2016-2017 of \$770,667.00.

L. Adams

The Commission is also members of an organization representing the Personnel Commission of Southern California, The Schools Association, CODESP, and other fees. These fees are also included into the budget totals along with any legal fees and New Employee packets.

Adams-Vickers

Can we please receive a New Employee Packet of information, for examination purposes only? This is an expense that we would like to take a look at for 2016-2017 school year. Are we using Neo Gov for our testing?

L. Adams

No, Neo Gov is applicant tracking system, CODESP is testing agency, and the cost for those two programs is \$9999.00 per year.

J. Irving

Is there enough money in the budget for the programs that we need to support and the conferences that we need to attend as well?

L. Adams

There is money for four different conferences in October. So the Commission will choose what conference they would like to attend. The conferences are in October 2016 this year. The Commissions conflict council will meet on Monday regarding conflicts that may arise in the future.

The statement is that the current budget is the minimal amount of \$770,667.00. We did not ask for additional funds for this year. We have sufficient funds for this school year of 2016-2017.

If our budget today is the same as the upcoming year for us, can we show a slight increase in our budget for this upcoming year 2016-2017?

L. Adams

No, because we received more than enough. We received an additional amount of \$40,000.00 in salary savings for last year, any there were other enhancements, so we are in good financial shape for this year. We also have reserves in place to support the departmental needs.

The money is used for employee development as well. I am very satisfied with our budget. We always consider what is needed for each year.
