I. <u>DESCRIPTION OF POSITION</u>

Under the direction of the Sr. Director of Secondary Educational Services, the adult school principal administers an adult school and satellite sites, serves as the instructional leader for the professional and para-professional staff assigned to the sites and is responsible for management of all aspects of the school's operation, including: educational programming, supervision of all instruction, supervision and evaluation of certificated and classified employees, communication with the school community, supervision of school in-service programs, compliance with all federal, state and district laws, regulations, policies and requirements, and other related work as required.

II. MAJOR DUTIES AND RESPONSIBILITIES

- A. Serves as administrative and instructional leader of the school.
- B. Provides for continuous supervision and evaluation of the prescribed instructional program.
- C. Supervises the establishment of the school master schedule and the assignment of teachers.
- D. Provides orientation and in-service training for professional and classified staff.
- E. Interprets school programs to the community and directs and supervises both certificated and classified personnel assigned to the site.
- F. Is responsible during school hours and school functions for the health, safety, welfare and morale of all personnel and students.
- G. Consults with teachers, and students regarding pupil progress, welfare, discipline and attendance.
- H. Coordinates the development, selection or procurement of instructional materials and equipment.
- Coordinates essential auxiliary services, such as health, recreation, food services, transportation and maintenance.
- J. Directs the appropriate organization of student body activities and establishes liaison with appropriate agencies and interest groups.
- K. Prepares and submits preliminary budget requests and administers program budgets.
- L. Implements the district's comprehensive evaluation program for certificated and classified personnel.
- M. Develops and maintains effective public and community relations programs and interprets the school program to the community.
- N. Implements and evaluates student behavior management programs.
- O. Maintains a proper school environment for students and employees.
- P. Follows a planned professional growth program, participates actively in local, state and national professional education and administrator associations, and studies local, state and national guidelines for effective school administration services.
- Q. Fulfills other duties as assigned.
