Compton USD Board Policy

Tobacco-Free Schools BP 3513.3 **Business and Non-instructional Operations**

The Board of Trustees recognizes the health hazards associated with tobacco products, including the breathing of second-hand smoke, and desires to provide a healthy environment for students and staff. Employees are encouraged to serve as models for good health practices that are consistent with the district's instructional programs.

The Board prohibits the use of tobacco products containing tobacco and/or nicotine, including, but not limited to, smokeless tobacco, snuff, chew, clove cigarettes, and electronic nicotine delivery systems, such as electronic cigarettes, any time, in CUSD schools or school district-owned or leased buildings, on school or district property, and in school or district vehicles. However, this section does not prohibit the use or possession of prescription products, or other cessation aids such as nicotine patches or nicotine gum. Student use or possession of such products must conform to laws governing student use and possession of medications on school property. Other vapor emitting electronic devices, such as electronic hookah, with or without nicotine content, that mimic the use of tobacco products, are also prohibited, at any time in district-owned or leased buildings, on district property, and in district vehicles. (Health and Safety Code 104420; Labor Code 6404.5; 20 USC 6083)

Districts Receiving TUPE Funds

These prohibitions apply to all employees, students, and visitors at any school-sponsored instructional program, activity, or athletic event held on or off district property. Any written joint use agreement governing community use of district facilities or grounds shall include notice of the district's tobacco-free schools policy and consequences for violations of the policy.

Smoking means inhaling, exhaling, burning, or carrying of any lighted or heated cigar, cigarette, pipe, tobacco, or plant product intended for inhalation, whether natural or synthetic, in any manner or form, and includes the use of an electronic smoking device that creates aerosol or vapor or of any oral smoking device for the purpose of circumventing the prohibition of

smoking. (Business and Professions Code 22950.5; Education Code 48901)

Tobacco products include (Business and Professions Code 22950.5; Education Code 48901)

1. Any product containing, made, or derived from tobacco, marijuana or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any other means, including, but not limited to, cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, marijuana or snuff

2. An electronic device that delivers nicotine or other vaporized liquids to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, pipe, or hookah

3. Any component, part, or accessory of a tobacco product, whether or not sold separately

This policy does not prohibit the use or possession of prescription products and other cessation aids that have been approved by the U.S. Department of Health and Human Services, Food and Drug Administration, such as nicotine patch or gum.

Smoking or use of any tobacco-related or marijuana-related product and disposal of any tobacco or marijuana-related waste is prohibited within 25 feet of any playground, except on a public sidewalk located within 25 feet of the playground. In addition, any form of intimidation, threat, or retaliation against a person for attempting to enforce this policy is prohibited. (Health and Safety Code 104495)

Pursuant to law, the County Office shall assure the maintenance of a tobacco and marijuana-free workplace by:

1. Publishing a statement notifying employees and students of the policy and specifying actions to be taken against employees who violate it;

2. Displaying signs stating the prohibition of tobacco and marijuana use at all entrances to all properties and vehicles owned or leased by CUSD;

3. Publishing information to the larger community and students that the use of tobacco or marijuana products is not permitted at any time on any property or vehicle owned or leased by the office or at any office-sponsored event:

4. Taking appropriate personnel action, up to and including termination, within 30 days of receiving notice with respect to any employee who is in violation of the Tobacco and Marijuana-Free Workplace policy;

5. Informing employees and students about the availability of tobacco or marijuana cessation and employee assistance programs;

6. Making a good-faith effort to continue to maintain a tobacco and marijuana-free

workplace.

All district administrative and instructional sites, properties, vehicles, and district-sponsored events shall comply with Board Policy 3513.3, Tobacco and Marijuana-Free Schools and Facilities.
